#### **Guidelines**

Honorary Life Membership is recognised by the Yass Football Club as the highest recognition that can be awarded to a member in acknowledgement of significant service and contribution. Therefore it can only be awarded in exceptional circumstances to retain its prestige.

In considering the award of Life Membership an individual should have demonstrated significant, sustained and high quality service <u>enhancing the reputation and future of the club</u>. Achieving minimum service levels does not automatically guarantee the award of Life Membership.

The award is intended to recognise a broad contribution, more than simply being a long-term member

Life Membership is presented to worthy recipients and not necessarily each year.

#### **Procedure**

- Nominations must be received by the Club Secretary by the general meeting <u>prior</u> to the AGM.
- Nomination for the award must be in writing and include the nominee's significant contribution to the club.
- Nomination for Life Membership will be verified and decided upon by the elected Life Membership panel elected at the AGM.
- If a Life Membership nominee is a member of the Life Membership panel, he/she will stand aside. A replacement panel member may be appointed by the general committee.
- Guidelines, criteria and/or process for the awarding of Life Membership can only be amended or altered at an Annual General Meeting or Special General Meeting of the club with due notice to members of the club.

#### Criteria

#### The nominee

- must display a general attitude and overall character to ensure that the attitude is one that reflects a dedication to the values of the club
- must display a commitment to the principals of good sportsmanship
- must display leadership and role modelling that reflects credit upon the club
- must have represented the Yass Football Club as an administrator, coach, manager, player or other support role and/or
- be recognised as an integral part of the development of the sport.
- must have exhibited a standard of behaviour that is fair, ethical and above reproach in relation to the rules and regulations of the game
- length of service to the club should be significant in either or both, on field and off field roles. Playing service <u>only</u> is not considered 'significant' in awarding Life Membership.

#### **Presentation of Award**

- Presentation of the award of Life Membership will be presented at an annual presentation function, either junior or senior
- The award will be acknowledged with
  - the presentation of a commemorative pin
  - a Life Membership trophy
  - listing on the club website (preferably with a photo)
  - invitation to all club functions
